

SCAN Rural Voters National Survey Key Findings

November 2022



Methodology

New Bridge Strategy conducted a survey among N=1,006 registered voters in rural counties nationwide from November 9-20, 2022. Rural counties are defined as those considered "mostly rural" or "completely rural" by the U.S. Census. In addition, respondents had to identify as living in a "rural area" or "small town." Interviews were conducted online for the national sample, and online and via live telephone interviews (both cell phones and landlines) for the target state samples. Interviews were distributed proportionally throughout the country by state. Quotas were set for key demographic subgroups, such as gender and age.

The credibility interval is $\pm 3.5\%$ for the overall national sample. The credibility interval will vary for sub-groups.

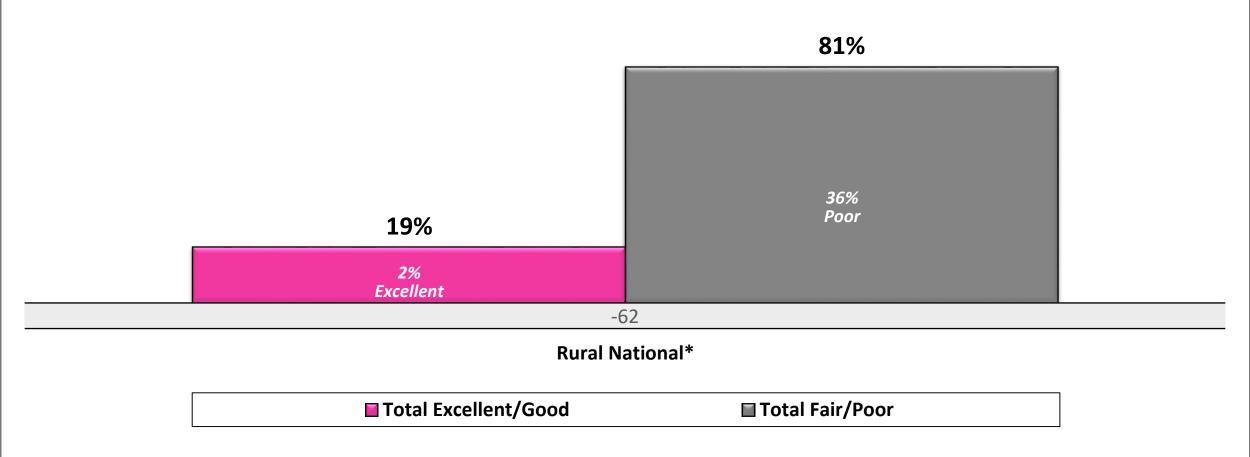


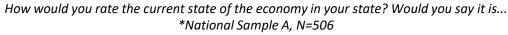


State of the Economy



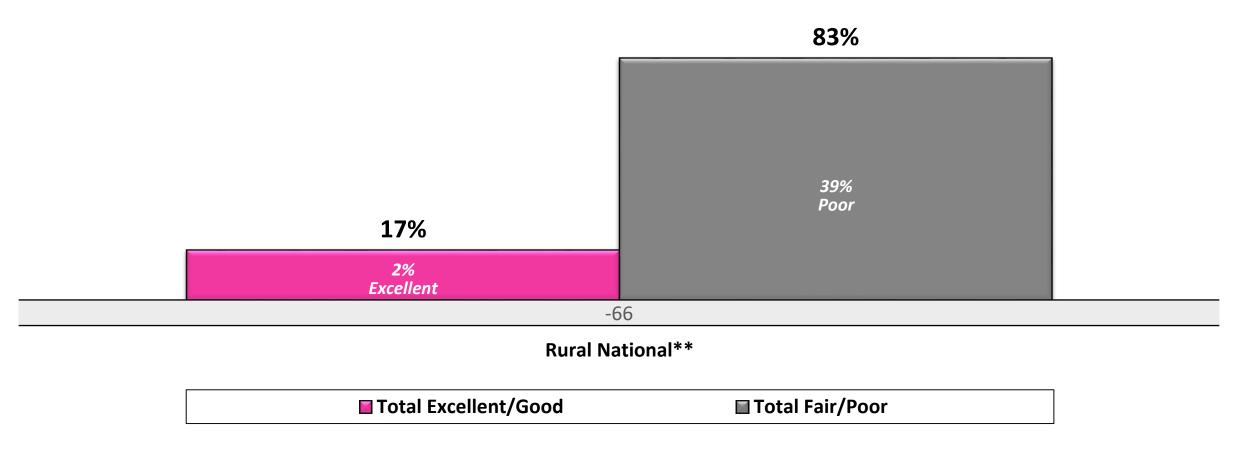
More than four-in-five rural voters say the economy "in their state" is fair or poor.

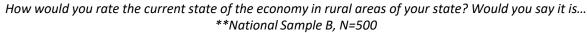






The response is basically the same when asked to characterize the rural economy in their state.





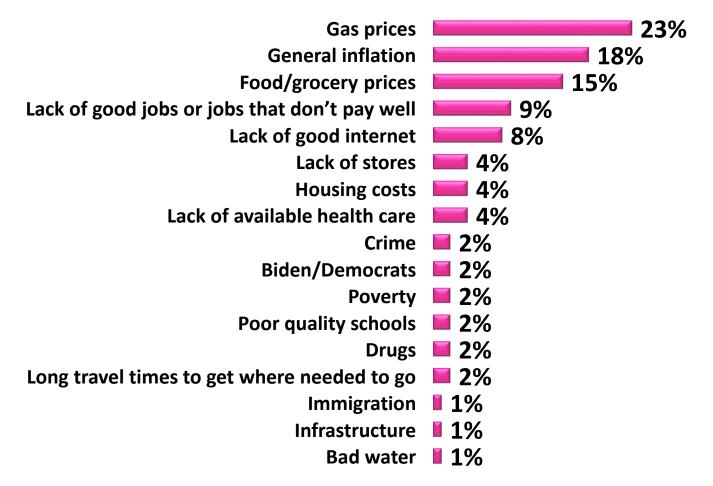




Challenges Facing Rural Families

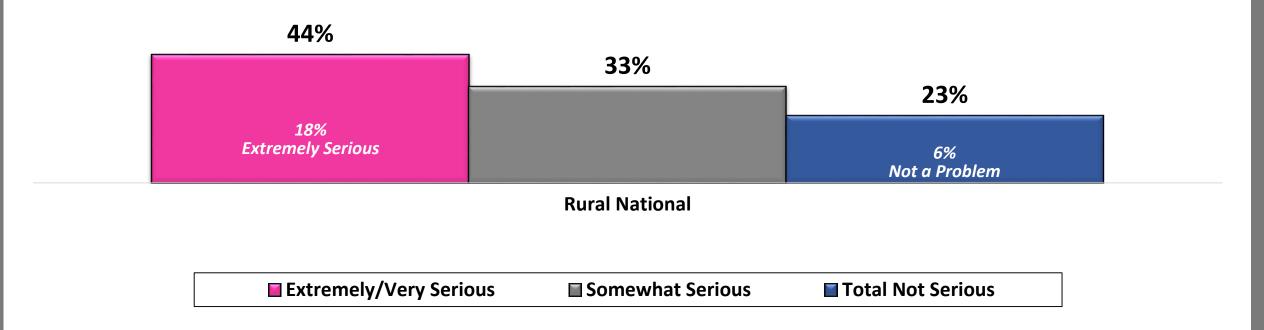


Child Care and Early Education

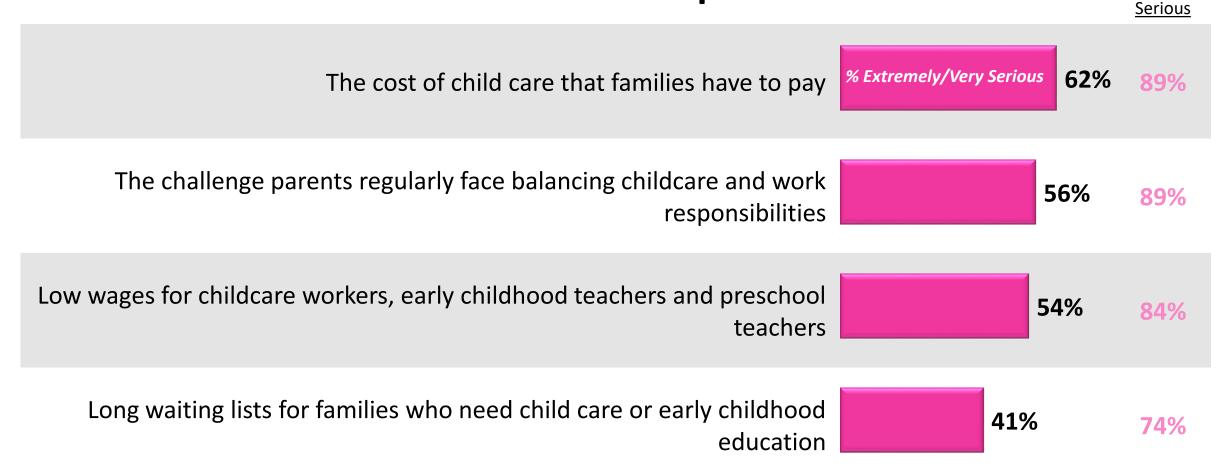
Among rural voters nationally, the lack of quality, affordable child care is seen as a bigger problem by those who are younger, women, parents, and have younger children.

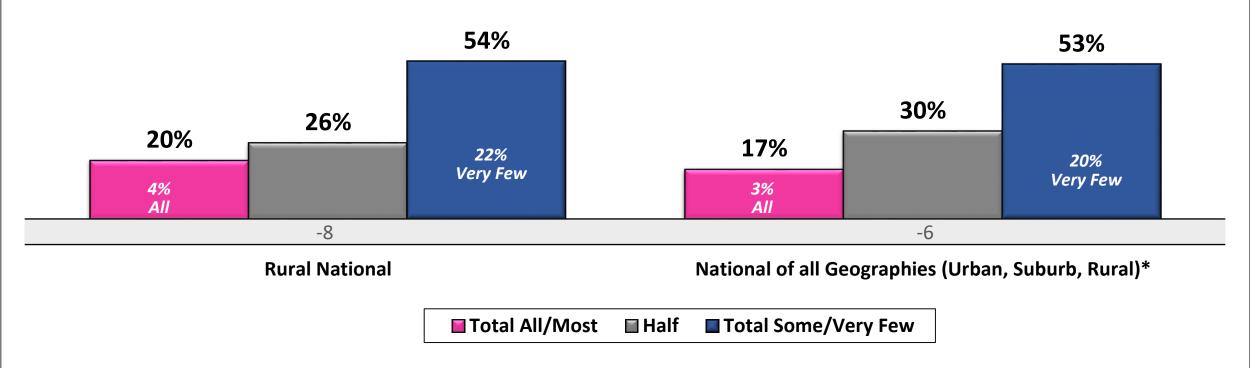

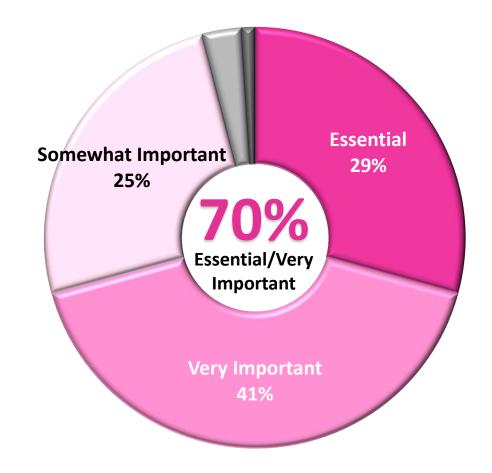

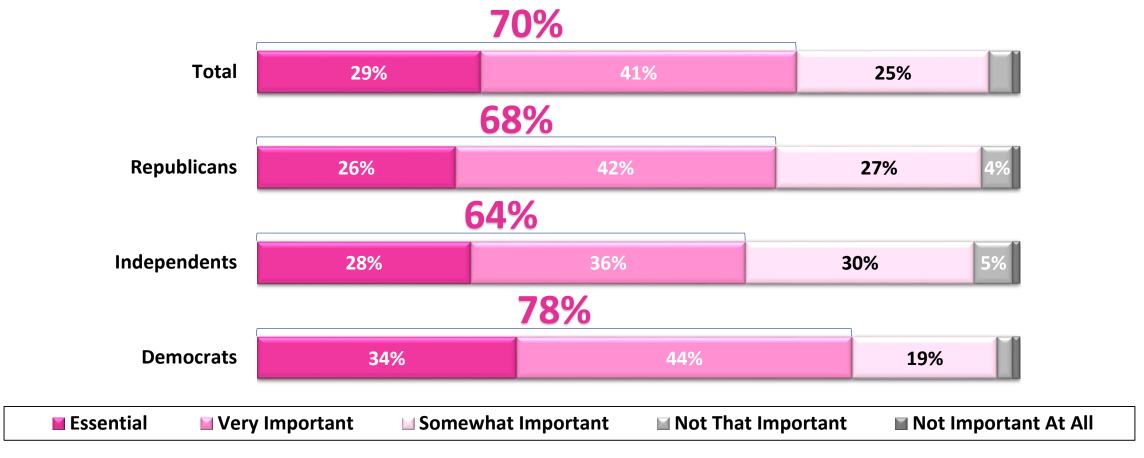
Nearly all rural voters say access to high-quality, affordable child care is important to strengthening the economy and helping workers.

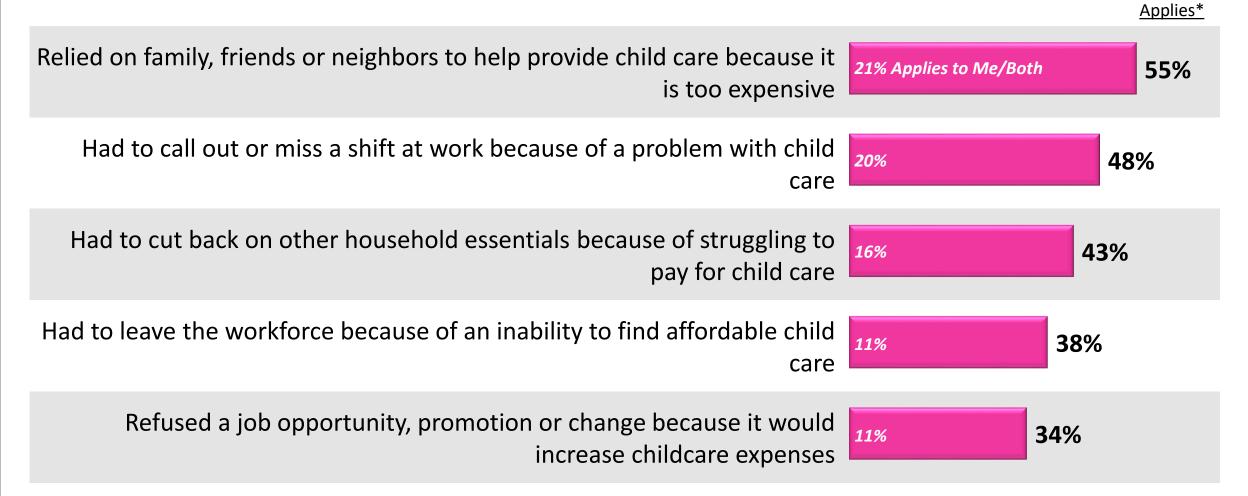

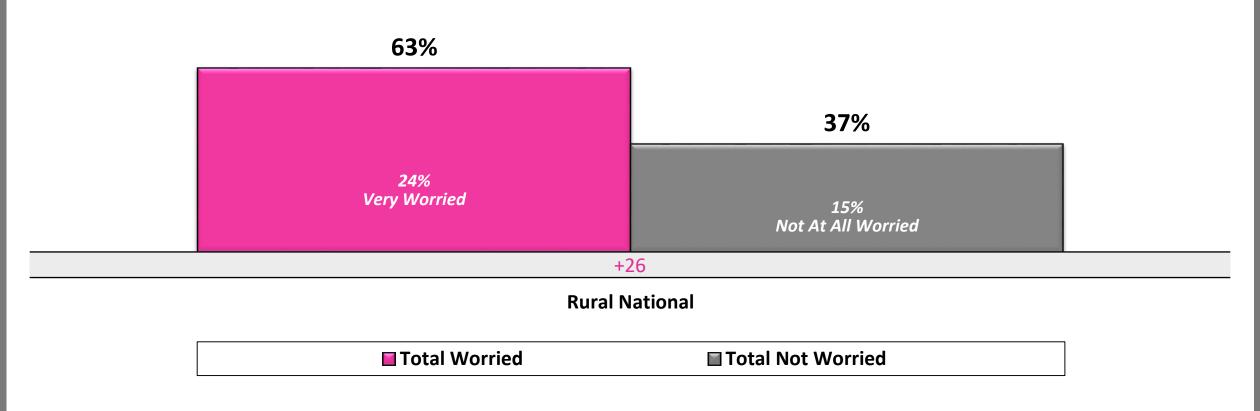

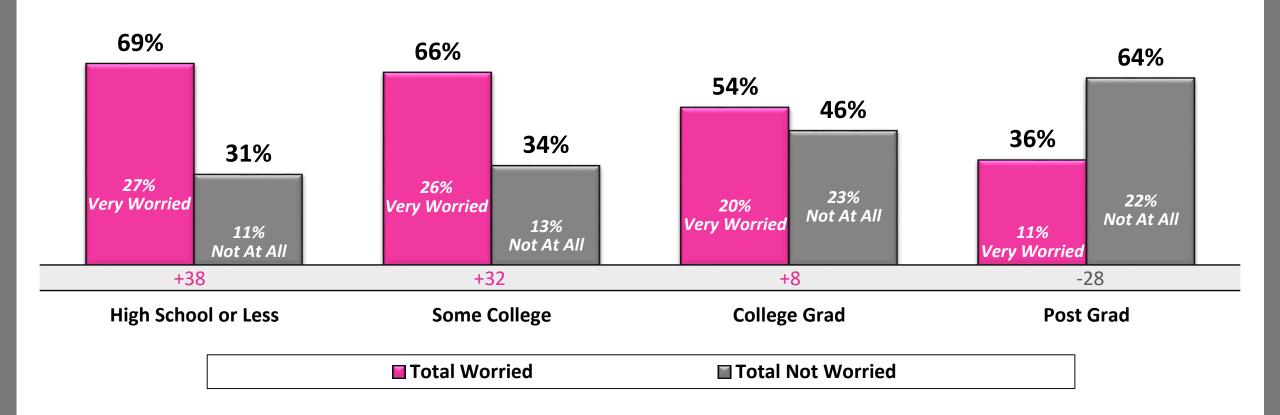
A majority of rural voters are worried that they might not be able to afford enough food to feed themselves and their family over the next year.



Thinking ahead over the next year, how worried are you that you might not always be able to afford enough food to feed yourself and your family?



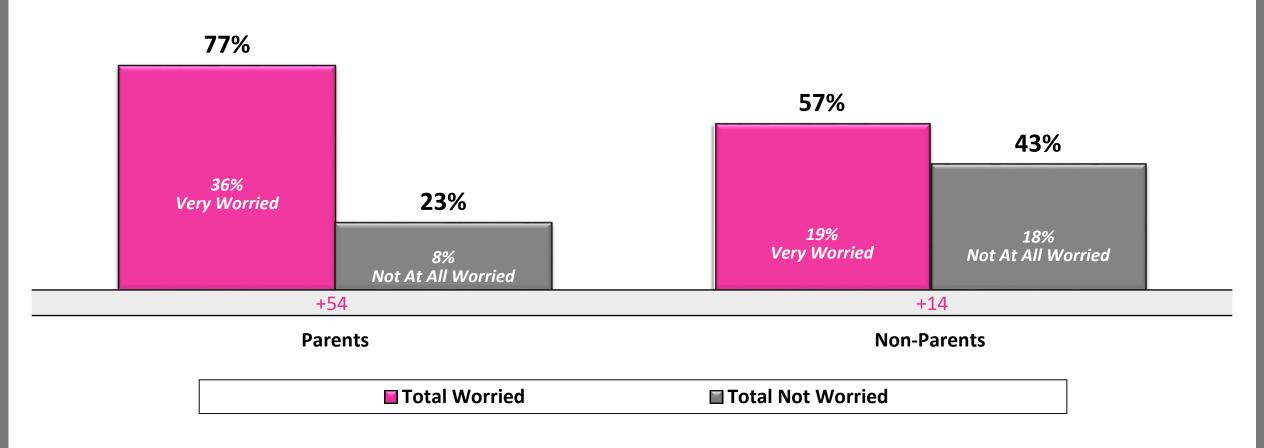
Rural voters with less education are more likely to be worried about being able to afford enough food.

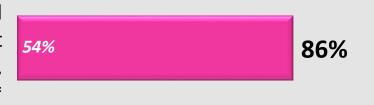
